Manager's Report by Josh Bailey

This year, only two Oregon Counties received a Governor's Declaration of Drought (Jefferson and Lake) as opposed to twelve last year. Hydrologic conditions are improving yet still remain below average. For example, the live flow (natural runoff) in the Deschutes River on September 12, 2024, was 1,049 CFS. Based on historical data, the normal flows for this time of year should be 1.244 CFS with a max flow of 1,597 CFS and a minimum flow of 762 CFS. The US Drought Monitor has listed Jefferson County as D1 (Moderate Drought). Overall, conditions are trending in a positive direction, but efforts in modernization, efficiency, and conservation need to continue.

The District recently awarded Taylor Northwest the construction contract for Segment 2 of our Lateral 43 Pipeline project. The project involves installing approximately 6 miles of High-Density Polyethylene (HDPE) Pipe ranging from 63" to 8" in diameter, including 26 new pressurized deliveries. Construction activities started on October 15, 2024, and will include the following laterals: 43-2, 43-3, 43-5, and the Main 43 lateral through Highway 97 and Highland Avenue. For those familiar with the area, construction will stop near the 43-7 lateral downstream of Highland Avenue.

Additional Fall/Winter projects include lin-

ing a section of the District's main canal near Feather Drive in Culver, continued work on the Lake Billy Chinook pumping plant feasibility analysis, NUID main diversion fish screen replacement, Floating Solar Project, Wickiup Dam outlet works automation, 58-11 measurement flume and automation upgrade, and multiple hydroelectric and hydrokinetic projects. Efforts will be made to seek funding and innovative ways to "Deliver water to District patrons by managing and maintaining the system in the most efficient and cost-effective manner possible," as stated in our Mission Statement



Canal Easements/Right-of-Ways

Reminder to please keep in mind before you build any structure, fence, put up a haystack, park equipment, plant trees /vegetation, irrigation lines, etc. near a canal or ditch that you check with the district office to obtain the size and location of the district's easement/right-of-way.

The district's easement/right-of-way can vary 10 feet from the center of a anal/ditch up to 250 feet on both sides of the canal/ditch.

It is also important to remember canal roads exist solely for the purpose of

operating and maintaining the district. In some circumstances the property owner may use the canal road, but only for purposes which do not interfere with district operation.

In no circumstance may the roads be used as a means of public access. Easements and the lands containing the district's service roads are nearly all privately owned. Therefore permission to walk or ride on many of the district's service roads may be required from the underlying landowner to avoid trespassing.

Ownership, Lease and Billing Changes

Water rights are appurtenant to the land and as such it is important to keep the District informed of any ownership changes. The ownership records determine who is responsible for the charges of the District and also who is allowed to vote on District matters. Recorded documents resulting from changes in ownership due to a sale of the property, putting property into a trust, estate, marriage, divorce or death must be provided to the District.

Please notify the District of any lease and/or rental changes on your property.

This information is used to determine who is allowed to order water on your property and who is allowed to bunch the water for excess purposes. The District as a courtesy will bill the responsible parties, but the landowner is ultimately responsible for all charges. If you have an agreement with a lessee or renter, please notify the District to enable us to bill the appropriate person. Statements are mailed the first part of December; it would be extremely helpful if you would provide the District with all changes before the end of November.

Do you have irrigation system changes?

If you have an existing pivot, are planning to install a pivot, or changing your irrigation practices, please check with the district office regarding the water rights on the property.

The place of use and the location of water rights are crucial when proving beneficial use!

Routine O & M

After the irrigation season draws to an end, please remember that District crews will be out working to remove trees and vegetation from canals and easements as part of routine Operations and Maintenance. To keep things running smoothly please make sure all irrigation and other equipment are removed from the district's easements. Equipment and items left in easements can interfere with maintenance operations and cause damage to both district and patron equipment. As such, the district is not responsible for irrigation or other equipment left in the easement, that is damaged.
